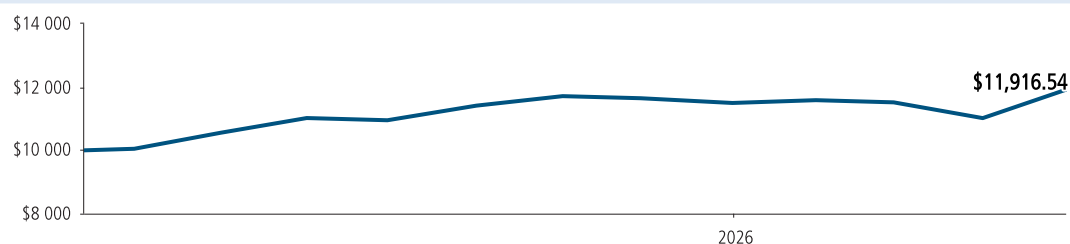

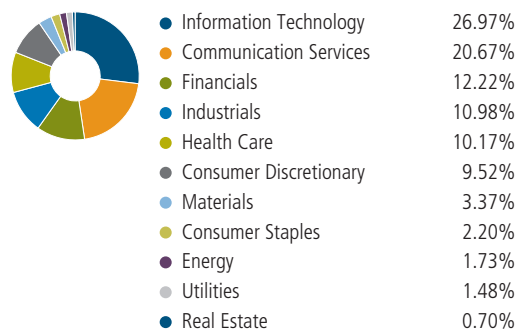

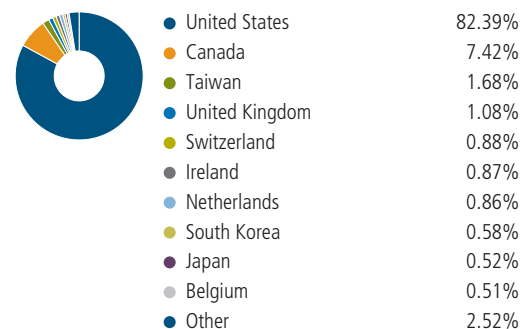

Sector Allocation



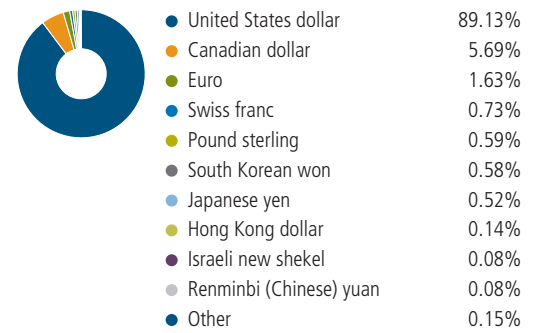
Geographic Allocation
