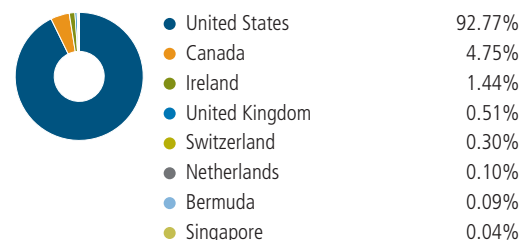

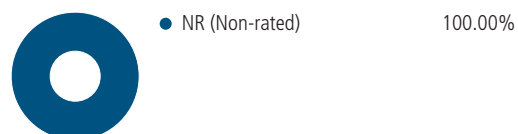
Sector Allocation



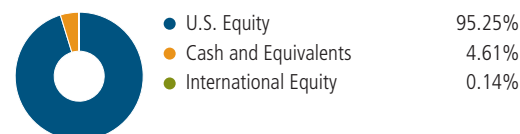

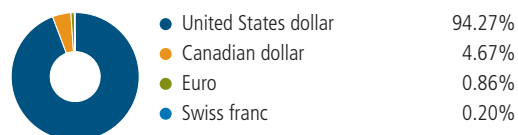
